



COMPETITION TERMS AND CONDITIONS

General Terms

1. All information on how to enter this competition forms part of these terms and conditions of entry. These terms and conditions exist in conjunction with the terms and conditions of the prize supplier. Entry into this competition is deemed acceptance of these terms and conditions and the prize supplier's terms and conditions.
2. This competition is run by City of Parramatta Council (ABN 49 907 174 773) of 9 Wentworth Street, Parramatta NSW 2150 (**Promoter**).
3. The Promoter reserves the right at any time to disqualify any individual who the Promoter reasonably believes has breached any of the terms and conditions or engaged in any unlawful or other improper conduct, calculated to jeopardise the fair and proper conduct of the competition.
4. The Promoter is not responsible for any incorrect or inaccurate information or for any fault in the equipment utilised in this competition, which may result in error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to or alterations of entries.
5. The Promoter may suspend, cancel, or vary the competition at any time. The Promoter will not be responsible for any loss incurred by the entrant in relation to such suspension, cancellation, or variation.
6. To the extent permitted by law, the Promoter will not be liable for any injury, damages, expenses, or loss whatsoever (whether direct or consequential) to persons or property, as a result of any person entering into the competition or accepting or using any prize.

How to Enter

9. To enter, entrants are required to complete and submit an online entry via the Participate Parramatta platform on the 'Share Your Favourite Local Spots' page at <https://participate.cityofparramatta.nsw.gov.au/photo-competition-dec-2025> and subscribe to the Participate Parramatta e-newsletter (or provide updated demographic details if already subscribed to the Participate Parramatta e-newsletter) between 10 December 2025 and 5 January 2026 (**Entry**).
10. Entrants can only submit one Entry per person.
11. The competition opens at 9am (AEDT) on Wednesday 10 December 2025, and closes on Monday 5 January 2026. No responsibility will be accepted for late, lost, or misdirected Entries.
12. The competition is only open to entrants residing in New South Wales.
13. Employees of the Promoter and their immediate family members are not eligible to enter this competition.
14. All entrants must be 18 years and over.

15. Upon request by the Promoter, the entrant must provide further information in relation to their Entry.
16. The Entry must be the entrant's own original work. By entering the competition, the entrant warrants that the Entry does not infringe the intellectual property rights of a third party. 31. **Intended recipients:** The intended recipients of this information are Council employees and contractors working on behalf of Council.
32. **Supply:** The supply of this information is voluntary. If you do not provide this information, Council may be unable to provide access to its services or respond to your enquiry. If you are under the age of 18 years of age, you will need the consent of your parent or guardian to disclose personal information as defined under the Privacy and Personal Information Protection Act 1998 (NSW).
33. **Access/Correction/Amend:** The information collected can be accessed by you and may also be available to third parties in accordance with Council's [Privacy Management Policy](#) and [Privacy Management Plan](#). You may make an application for access or amendment to personal information held by Council. Council will consider any such application in accordance with the Privacy and Personal Information Protection Act 1998 (NSW). In the event you are under the age of 18, your parent or guardian may make an application for access or amendment to personal information held by Council about you.
34. **Storage:** Council is the agency that holds the information and will store it securely.
35. **Other uses:** Council will only use your personal information for the purpose for which it was collected and will not use your personal information for another purpose unless:
 - (a) you have given your consent, or
 - (b) the other purpose for use is directly related to the purpose for which your personal information was collected, or
 - (c) the other purpose for use is necessary to prevent or lessen a serious and imminent threat to the life or health of any person.

(Note: Health information cannot be used for a secondary purpose unless the individual has consented to this other use, or it is directly related to the primary purpose).
